

About David Dixon and his topic, The Lost Gettysburg Address

David Dixon earned his B.A. in Political Science from the University of California and his M.A. in History from the University of Massachusetts. He spent 35 years in marketing with Fortune 500 companies. David published numerous articles in scholarly journals and magazines. Most have focused on black history and Union supporters in the Civil War South.

David's website is called "B-List History." It focuses on historical figures who were important in their time, but are all but forgotten today.

Recently, David published his first book, *The Lost Gettysburg Address: Charles Anderson's Civil War Odyssey*. The biography received widespread acclaim. David has since spoken at the 2016 Sacred Trust Talks at the Gettysburg, been interviewed on Civil War Talk Radio and has made appearances at historical societies, libraries, conferences, and private clubs across the country. He is one of the most popular speakers on the Civil War Round Table circuit.

David's book recounts the unusual life story of Charles Anderson, a slave owner who sacrificed nearly everything to help Lincoln save the Union. Anderson's speech, which followed Lincoln's at Gettysburg on November 19, 1863, remained lost for nearly 150 years until it was discovered recently. A transcript of this speech, along with rare photographs and a hand-drawn map of the Stones River battlefield, are all published in Dixon's book for the first time.

Currently, David is writing the first full-length biography of Union General August Willich, a German 48er who distinguished himself in a number of important battles.

A Woman's Place...Is in the War Taken from Wikipedia



Susie King Taylor was born a slave at a plantation in Liberty County, Georgia, on August 6, 1848, as Susan Ann Baker. When she was about seven years old, her owner allowed her to go to Savannah to live with her grandmother, Dolly. Taylor's admiration for women may have stemmed from her close relationship with Dolly. Despite Georgia's harsh laws against the formal education of African Americans, Dolly, with whom Taylor lived for much of her childhood, supported Taylor's education by sending her to an illegal school run by a free African-American woman, Mrs. Woodhouse. After learning all she could from Mrs. Woodhouse, Taylor continued her education under the tutelage of various "teachers", both white and black, including playmates, and the son of her grandmother's landlord. From them she gained the rudiments of literacy, then extended her education with the help of two white youths, both of whom knowingly violated law and custom. Her education ended when she was forced to return to her mother on the Isle of Wight after Dolly was arrested at a suburban church meeting for singing freedom hymns. Taylor had to move back with her mother in Fort Pulaski but Union took the fort not long after. Taylor fled with her uncle and his family to St. Catherine's Island, where they received Union protection and a transfer to St. Simons Island. Taylor impressed the commanding officers with her ability to read and write and was offered a

position running a school for children and adults on the island.

In April 1862, Susie Baker and many other African Americans fled to St. Simons Island, occupied at the time by Union forces. Within days her educational advantages came to the attention of army officers, who offered to obtain books for her if she would organize a school. She thereby became the first black teacher for freed African-American students to work in a freely operating freedmen's school in Georgia. She taught 40 children in day school and "a number of adults who came to me nights, all of them so eager to learn to read, to read above anything else." She taught there until October 1862, when the island was evacuated.

While at the school on St. Simons Island, Baker married Edward King, a black noncommissioned officer in the First South Carolina Volunteers of African Descent (later reflagged as 33rd United States Colored Troops February 8, 1864, which was disbanded at Fort Wagner in 1866). For three years she moved with her husband's and brothers' regiment, serving as nurse and laundress, and teaching many of the black soldiers to read and write during their offduty hours. In 1866 she and Edward returned to Savannah, where she established a school for the freed children. Edward King died in September 1866, a few months before the birth of their first child. There are few details about his death but scholars have noted that he died in a work-related accident at the pier unloading ships. Also around this time Taylor was forced to close her school when a free school opened nearby. In 1867 she returned to her native Liberty County to establish another school. In 1868 she again relocated to Savannah, where she continued teaching freedmen for another year and supported herself through small tuition charges, never receiving aid from the northern freedmen's aid organizations. Historians say she, Taylor enrolled as a laundress at a camp named "Camp Saxton".

In the 1870s King traveled to Boston as a domestic servant of a wealthy white family. While there she met Russell L. Taylor, also a native of Georgia. She returned home to Liberty County to marry Taylor on April 20, 1879. She remained in Boston for the rest of her life, returning to the South only occasionally. Taylor still kept in contact with her fellow veterans' group, the Grand Army of the Republic. [6] After a trip to Louisiana in the 1890s to care for a dying son, she wrote her *Reminiscences*, which were privately published in 1902. She died 10 years later. She is buried next to her second husband at Mount Hope Cemetery in Roslindale, Massachusetts.

Kudos to Wayne Schaeffer for locating a gem of an activity. At a recent visit to Gettysburg, Wayne gained permission to see Neill (Lost) Ave. It is the only avenue in the park that has not been paved and it is on private property. It is the place where the 2nd VA. Infantry fought Neill's Brigade at the extreme right end of the union line. Wesley Culp was in the 2nd VA. Infantry which adds an additional interest to this portion of the battlefield. The owner and guide, Dean Schultz suggested a start time of 9:30 because he has in mind to do a personal tour in two segments; The first takes about 2 1/2 hours and includes starting at his barn, the overall big picture for this end of the battle, Neill Ave and possibly McAllister's Mill. The second portion would continue on to the Z. Taney farm and Spangler's Spring which will be a total time of about 4 hours. If someone decides to leave after the first portion they may go back to their car and leave prior to the second portion beginning.

We are planning on leaving from the Holiday Inn at Fogelsville at 7 am on October 28, 2017 and car pooling as we ususally do. If you could contact Wayne, Barry, or myself at any one of the e mail addresses below and just let us know you plan on attending. We are including the parking directions in the event that you prefer to meet us there. It would still be nice to know if you are coming so we can keep an eye out and try to not get started until everyone is there. Please feel free to bring a friend or two. We are asking a \$5.00 donation per person to present to Mr. Schultz for his favorite preservation endeavor. Also we would like your cell numbers so we can use that as a way to communicate th3 day of the trip.

Lincoln Sites in Springfield, Illinois by **Paul Bartlett**

Abraham Lincoln, the President who led the nation during the years of the Civil War, had deep roots in Illinois. On a recent trip to that state, my wife and I had a chance to visit a few of the sites in Springfield, which featured prominently in Lincoln's life and death.



The <u>Lincoln Home National Historic Site</u> preserves the Springfield, Illinois home and the historic oved to Springfield from New Salem at the start of his self-educated law career. He met his wife, Mary Todd, at her sister's home in Springfield and married there in 1842.

The historic-site house, purchased by Lincoln and his wife 1844, was the only home that ever owned. Their children, four there. Located at the corner of contains twelve rooms spread here, Lincoln was elected to the elected President in 1860. At this

house, friends and neighbors gathered to celebrate his election death.

The homes in the surrounding blocks have also been preserved and visitors can read descriptions of residents who were not only neighbors, but friends and even political opponents, in this integrated and diverse community.

In the adjacent Visitor's Center, the film, "Abraham Lincoln: A Journey to Greatness," plays every half-hour and describes Lincoln's rise to power and his pre-Civil War efforts to resist the expansion of slavery in the United States.



The <u>Lincoln-Herndon Law Offices</u> – Lincoln rented offices for his law firm in the commercial building across the street from the Illinois State House. The Tinsley building is the only surviving structure in which Lincoln maintained a law office. He partnered here with two others over the years and even argued cases before the federal courts which heard cases in a second floor courtroom. The building is not open for tours, but the exterior is preserved as it was in the days of Lincoln.

The Old State House was built from 1837-1840 when the state capital was moved from Vandalia to Springfield. The building contained chambers for both houses of the General Assembly, offices for the Governor of Illinois and other executive officials, and a chamber for the Illinois Supreme Court. It was in this building that Lincoln served his final term as a state lawmaker in 1840–41. It was here, as a lawyer, that he pleaded cases before the state supreme court in 1841–60. It was here, in the Illinois House chamber, that he made his "House



Divided" speech in June 1858, announcing his candidacy for the U.S. Senate; and it was to the same chamber, in May 1865, that his body was returned, arriving from Washington, D.C. prior to final burial in Springfield's Oak Ridge Cemetery.



The <u>Lincoln Tomb State Historic Site</u> is the final resting place for Lincoln, his wife Mary, and three of their four sons: Edward, William, and Tad (Robert is buried at Arlington National Cemetery.) It has a huge granite base supporting an obelisk over 100 feet tall. At the corners of the shaft, there are four bronze sculptures representing each of the four Civil War military services—infantry, artillery, cavalry, and navy. The Gettysburg Address is inscribed on a bronze plaque above the entrance.

Visitors enter into a rotunda, where hallways lead to the burial chamber in the rear. Along the way are scale versions of important Lincoln statues, as well as plagues with excerpts from Lincoln's farewell address to
