

with Author, David C. Keehn



Based on years of research, David C. Keehn's study unveils the true history of the shadowy Civil War era secret society that initially sought to establish a slave-holding empire in the "Golden Circle" region of Mexico, the Caribbean, and Central America. Keehn reveals the origins, rituals, structure, and history of these mysterious "Knights", including their later involvement in the secession movement.

David C. Keehn

David Keehn is a full-time writer and lecturer who previously served as a regulatory attorney in a multifaceted career spanning forty years. David graduated cum laude from Gettysburg College as a History Major. He then went on to the University of Pennsylvania Law School where he received his Juris Doctorate and authored a Law Review article on vigilante organizations.

With his wife, who is a noted children's author, David co-authored a nonfiction book on Pennsylvania and has separately published a number of legal and Civil War articles. Among these is "Strong Arm Of Secession: The Knights of the Golden Circle in the Crisis of 1861" that appeared in *North & South* magazine (Vol. 10, No. 6, June 2008), which its editor described as "ground-breaking." This *North & South* article brought David's historical discoveries regarding the Knights to the attention of Dr. Michael Parrish from Baylor University and sponsor of the Conflicting World series for Louisiana State University Press.

David spent another four years unraveling the secrets of the Knights. He collected primary sources and rare images from archives and historical societies across the country. He expanded his research to encompass the nation-wide reach of the Knights and their rearguard activities during the Civil War. This includes John Wilkes Booth's involvement as a Knights' leader and the curious number of Knights involved in the 1861 and 1865 attempts to abduct or assassinate Abraham Lincoln. These have been revealed and documented in David's full-length book: *Knights of the Golden Circle: Secret Empire*, *Southern Secession*, *Civil War*.

David lives in Allentown, PA with his wife, where he is involved in a number of community organizations. He enjoys biking, traveling, researching and unraveling historical mysteries, and visiting his two grown daughters.



The Battle of Byram's Ford from Wikipedia

The **Battle of Byram's Ford** was a minor engagement of the <u>American Civil War</u>, comprising two separate skirmishes on October 22–23, 1864, in <u>Jackson County</u>, <u>Missouri</u>. It formed a part of the larger <u>Battle of Westport</u>, which ultimately resulted in a Union victory and the end of all major Confederate operations in Missouri. This battle is also sometimes referred to as the "Battle of the Big Blue River".

Maj. Gen. Sterling Price's Confederate Army of Missouri was headed westward towards Kansas City and Fort Leavenworth, hoping to capture Missouri for the South and negatively influence Abraham Lincoln's chances for reelection in 1864. Maj. Gen. Samuel R. Curtis's Army of the Border, in and around Westport, was blocking the Confederates' way west, while Maj. Gen. Alfred Pleasonton's provisional cavalry division was pressing Price's rear. Price had nearly 500 wagons with him, and required a good ford over the Blue River to facilitate passage of his supplies. Byram's Ford was the best crossing in the area, and would clearly be a point of great strategic significance during the impending Battle of Westport.


First engagement, October 22

On October 22, Maj. Gen. James G. Blunt's division held a defensive position on the west bank of the Big Blue River. Around 10 a.m., part of Brig. Gen. Joseph O. Shelby's Confederate division conducted a frontal attack on Blunt's men. This attack was a ruse, because the rest of Shelby's men flanked Blunt's hasty defenses, forcing the Federals to retire to Westport. The brunt of the Battle on October 22nd was born by about 300 of Col. Veale's 2nd Regiment of the Kansas State Militia (KSM), a mixed unit of infantry, cavalry, and artillery. Brigadier General M.S. Grant (KSM) ordered Col Veale's unit to use their howitzer to stop the Confederate onslaught. The major Battle started around 4p.m. and lasted about an hour before the 2nd Reg. KSM was overrun by Shelby's forces. About half of the 2nd Regiment at Bynam Ford was killed, wounded or captured. Price's wagon train then crossed the Big Blue River at Byram's Ford and headed south to the village of Little Santa Fe and safety. Ref: Samuel J. Second engagement, October 23

The Battle of Westport began in earnest on the morning of the October 23. Pleasonton's cavalry was hot on the tail of Price's army, having engaged his rear guard in nearby <u>Independence</u> the previous day. Brig. Gen. <u>John S. Marmaduke</u>'s Confederate division had stopped Pleasanton just west of Independence, and now held the west bank of the Big Blue at Byram's Ford to protect Price's rear from an expected Union attack.

Pleasonton began his assault on Byram's Ford around 8 a.m. Initially the Confederates held their own. One of the Union brigade commanders, Brig. Gen. Egbert B. Brown, stalled his attack and was placed under arrest by Pleasonton for disobeying orders. Another of Pleasonton's brigade commanders, Col. Edward F. Winslow, was wounded and succeeded by Lt. Col. Frederick Benteen, who later rode to fame at the Little Bighorn. Despite these setbacks, Federal troopers gained the west bank by 11 a.m. and Marmaduke retired. As Brown's brigade (now led by Col. John F. Philips) forded the river, they came under heavy fire from Confederate artillery. Once they had crossed, they charged Marmaduke across an open field; during this charge, Union troops from Missouri and Arkansas battled Confederates from these same two states. As Marmaduke rejoined Shelby and Fagan, Blunt pounded the consolidated Confederate forces with his own



Aftermath

With Pleasonton now across the river he was now an additional threat to Price, who was heavily engaged with Curtis's main force at Westport. Defeated by Curtis there and menaced by Pleasanton and an additional Federal brigade under <u>John McNeil</u>, Price had to abandon his Missouri campaign and retreat southward. This brought to a close the last major Confederate military operation west of the <u>Mississippi River</u>, and ended the last major Southern threat to any Northern state.
